Sharpe stated the Rush County Players are using the Amphitheater for June 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> and 13<sup>th</sup>, 14<sup>th</sup> and 15<sup>th</sup>. They are asking permission to use the curtains on the back wall only. After further discussion C. Stout made a motion to not allow the use of the curtains. Binder seconded the motion. Motion carried.

Stout suggested moving the meetings back to the Amphitheater next month.
